From the Minister's Desk

Telangana the youngest state in the country turns four this year. It is a matter of great pride as I review the developments of the Industries and Commerce Department over the past financial year of 2017-18. Upping our stellar GSDP performance from last year, we have touched a new high this year with a growth rate of 14.1% at current prices and 10.4% at constant (2011-12) prices, compared to 13.7% and 10.1% resp. from last year. Interestingly, the national GDP has shown a downward trend moving from 7.1% to 6.6% from 2016-17 to 2017-18, whereas Telangana moved from 10.1% to 10.4% in the same period showing a positive growth



trend. The share of Telangana's economy in the National GDP has increased 9 basis points from 4.28% in 2016-17 to 4.37% in 2017-18.

In 2018, Hyderabad has retained its ranking as the top Indian city fourth year in a row for 'quality of living' index by Mercer. This year, Telangana has again retained its No. 1 position in Ease of Doing Business. Due to our proactive and investor friendly environment we have attracted cumulative investments of Rs. 1,23,478 Cr. through our flagship initiative of TS-iPASS creating an employment of about 5.27 Lakh jobs. Many important mega investors are now setting up their operations in Telangana including Safran, Youngone, Adani, RPSG group, Welspun, ISE foods, Patanjali and so on. We brought important global summits such as the GES and WCIT to Hyderabad for the first time.

I am happy to announce that our new initiative of Telangana Industrial Health Clinic (TIHCL) has received NBFC registration this year and is fully operational as a fintech company from April 2018. Research and Innovation Circle of Hyderabad (RICH) is also gradually increasing its influence among the start-up community, corporates and local businesses. This year we have also launched the first Incubator for women entrepreneurs in India called We-Hub. It will provide a wide range of services to support women entrepreneurship and will work in collaboration with T-Hub, T-Works and TASK.

We are actively working on completion of important projects such as the Pharma city, MSME Green Industrial Park at Yadadri, Mega food park at Khammam, Kakatiya Mega Textiles Park etc. In order to encourage investments in priority sector of Handlooms and Textiles we have also launched Telangana Textile and Apparel Policy (T-TAP) last year. Many more sectoral policies such as Electric vehicle policy, food processing policy, retail policy and logistics policy are in pipeline. With the intent of supporting MSEs in Telangana, we are also working on Public Procurement Policy and Revival policy for sick MSEs.

I feel proud with the achievements of last year, however, I see that there is so much more that can be accomplished in the coming years. The tremendous growth possibilities fill me with great excitement and I hope we can continue working together and moving on the path towards a 'Golden Telangana'.

RECENT DEVELOPMENTS

Ford India and Hyderabad Metropolitan Development Authority (HMDA) signed a MoU to assess the feasibility of setting-up a common digital mobility solution for commuters in Hyderabad.

Tata, Lockheed Martin to open new facility of 4000 sq.mtrs at Adibatla. The facility will be India's first of its kind metal to metal bonding facility.

Cyient Ltd inked a joint venture deal with Israel-based drone maker BlueBird Aero Systems to build and assemble indigenous Unmanned Aerial Vehicles (UAV) at its Hyderabad facility.

Two Azure powered Digital Empowerment Centers launched by Microsoft for weavers in Narayanpet. These Digital Empowerment Centers will train weavers in basic digital skills through Project Sangam, an Azure based skill training platform, and improve their marketing skills.

The Telangana government signed a technology partnership agreement with Taoyuan City, Taiwan on the side-lines of the World Congress on Information Technology (WCIT), 2018 to facilitate a collaborative atmosphere for entrepreneurship.

The Government of Telangana signed an MoU with NASSCOM to establish a Centre of Excellence for Data Science and Artificial Intelligence (CoE – DS&AI) in the State, on the side-lines of NASSCOM India Leadership Forum held in Hyderabad.

GE, Tata Group have entered into a partnership to pursue military engine and aircraft system opportunities in Telangana, focussing on the manufacturing of the LEAP Engine.

Attivo Economic Zones, an initiative of Kanoria Foundation entity Srei, and the Government of Telangana signed an agreement to develop an infrastructure equipment manufacturing park in the National Investment and Manufacturing Zone near Zaheerabad in Telangana over an area of 500 acres.

Most of the world's leading original equipment makers (OEMs) are expected to set up their units in the park, which has a potential to generate direct and indirect employment in excess of 10,000 over the next 10 years.




GROWTH

GSDP - Outlook for 2017-18:

- As per the advanced estimates released by the Directorate of Economics and Statistics, the Gross State Domestic Product (GSDP) at current prices for the year 2017-18 is estimated to be Rs. 7.33 lakh crore
- Impressive growth rate of 14.1 percent.
- Telangana GSDP at constant (2011-12) prices for the year 2017-18 is estimated at Rs.5.49 lakh crore
- · Highest growth rate of 10.4 percent, since the formation of State

Trends in GSDP and growth rates of Telangana






Performance of the state's economy in 2017-18

Comparison of growth rates of Telangana vis-à-vis all India






Comparison of growth rates of Telangana vis-à-vis all India at constant prices



Sectoral growth performance


- As per advance estimates for the year 2017-18, the Gross Value Added from the primary sector including agriculture and allied activities is likely to grow at a pace of 9.2 percent at current prices, as against 5.3 percent anticipated growth of All India.
- The GVA from secondary sector which includes manufacturing, electricity and construction is expected to register a growth rate of 9.0 percent, as against the All-India growth rate of 7.6 percent.
- Services sector is anticipated to register an impressive growth of 15.3 percent GVA at current prices, in comparison to the All India growth rate of 12.2 percent.
- The total GVA comprising all three broad sectors is likely to register an impressive growth of 13.1 percent, which is 3.5 percent higher than that of All India GVA growth


Comparison of growth rates in 2017-18: Telangana vis-à-vis all India

TS-iPASS

Government of Telangana has enacted the "Telangana State Industrial Project Approval and Self-Certification System (TS-iPASS) Act, 2014" (Act No.3 of 2014) for speedy processing of applications for issue of various clearances required for setting up of industries at a single point based on the self-certificate provided by the entrepreneur and also to create investor friendly environment in the State of Telangana.

Single point online Processing

- The TS-iPASS approval process is totally online i.e. from application filing stage to approval stage without any human interface
- The departmental fee is collected online at a single point (TS-iPASS) and payment through demand draft, challan and other offline process are dispensed
- A total of 35 services from 27 Departments pertaining to pre-establishment and pre-operation of industries which covers all state level approvals are under the ambit of TS-iPASS

- Each approval has a fixed time line which has to be adhered by the department failing which the officer responsible for delay will be penalised @ RS.1000 per day and the provision of deemed approval will be revoked as per TS-iPASS Act
- Alerts are sent to the entrepreneur in the form of messages to the mobile and to the registered email at every stage of approval process
- The Development Permission Management Permission system (DPMS) is implemented for construction permits which harness the potential of Information and Communication Technology (ICT).
- The TS-iPASS Chasing Cell headed by the Principal Secretary to CM monitors the entire process of approval system in terms of time lines being followed. In case of delay in processing of the applications which makes the officers to be attentive and more responsive in issue of approvals within time frames and making the TS-iPASS system successful.

Achievements

The GOI in association with world bank has ranked Telangana state as first in EODB and TS-iPASS played a key role in achieving this. The steady and steep growth of the applications processed year after year showcases the scintillating performance of TS-iPASS

TSIIC

Telangana State Industrial Infrastructure Corporation Limited (TSIIC) is a Nodal Agency of Government of Telangana. The Corporation is mandated to identify and develop potential growth centers in the State by providing infrastructure through development of industrial areas.

Land Allotment in the Year 2017-18

- TSIIC developed 148 industrial parks with the entire core infrastructure during the financial year 2017 – 18
- Allotted land to an extent of 195.25 acres to 460 industries, with investment potential of Rs.1444.67 Cr. and employment for about 50,000 persons Shifting and Relocation of Polluting Industries

PHARMA & LIFE SCIENCES

The year 2017-18 has proved to be yet another phenomenal year for the Life Sciences sector in Telangana.

- The State was able to retain its leadership position in innovation and manufacturing despite the changing landscape of the sector globally, by contributing more than 35% to the national pharmaceutical production of the country
- The State is also proud to be recognized as the Vaccine Hub of India and the world, producing about 33% of global vaccines dosages and significantly contributing to the elimination of endemic diseases
- Export of active pharmaceutical ingredients (APIs) from the country stood at Rs 40,000 crore and about 40% of that came from Hyderabad
- Establishment and development of Genome Valley, Pharma City, Medical Devices Park makes Hyderabad a unique destination providing a complete ecosystem for Global Life Sciences companies

Genome Valley:

In FY 2017-18, India's first and largest successful life sciences innovation and clean manufacturing cluster – the Genome Valley was accorded with Industrial Area Local Authority (IALA) status.

- The IALA status enables single point administration of the cluster, which will allow companies in Genome Valley a single point contact for all Government related approvals and further facilitate infrastructure development in the cluster.
- Government has also announced launch of Genome Valley 2.0 giving a further impetus to the overall ecosystem, with expansion of Genome Valley cluster and formulating an integrated master plan (including development of social infrastructure, improving connectivity, etc.) for the cluster.

Genome Valley: Global and National Majors



Hyderabad Pharma City:

- Spread across 19,000 Acres, this would be the biggest greenfield project of its kind in the world, with plug-n-play facilities
- The cluster is designed to become the jump-start platform for companies that make bulk drugs, fermentation products, synthetic drugs, intermediates, vitamins, vaccines, drug formulations, nutraceuticals, herbal products, specialty chemicals and cosmetics
- The project received Environment Clearance from Ministry of Environment, Forest and Climate Change (MoEFCC), Government of India

Launching of Medical Devices Park

- Country's largest Medical Devices Park launched on 17th June 2017 in Sultanpur village of Sangareddy district by Minister for Industries Shri K.T. Rama Rao along with Irrigation Minister Shri T. Harish Rao
- In 250 acres, with a dedicated ecosystem for MedTech innovation and manufacturing
- Over 16 companies are already setting up facilities in the park and 20 more are in pipeline
- An MoU signed with China Medical City located at Taizhou for Knowledge / Technology Sharing purpose
- Another MoU signed with Gangwon Tech Park (South Korea) for Information Sharing and Know How Exchange

BioAsia 2018 Successfully Organized, with Unprecedented Participation

- The 15th edition of life sciences convention organized from February 22-24, 2018 was yet another successful event with participation of over 1,800 leaders from 52 countries
- More than 1,200 partnering meetings were conducted
- The event resulted in the setting up of an Innovator Cell at Central Drugs Standard Control Organization (CDCSO) by Government of India
- The CDCSO has also relaxed the requirement for NOC for export of consignments based on the recommendations at the event
- Other recommendations that emerged out of the event were also consolidated and has been presented to various Ministries / departments of Government of India for favourable consideration
- The State Government is committed to utilize this global platform to advocate the concerns of the industry and help build a conducive ecosystem for businesses to thrive
- During the event, an MoU for investment promotion was signed between the Selangor BioBay of Malaysia and TSIIC
- Selangor BioBay and TSIIC would support each other as promising hubs in the areas of preclinical and clinical research, pharmaceutical regulations, device development, manufacturing practices, and commercialization among others

Key Announcements/Initiatives during FY 2017-18

- Biocon would establish an R&D unit in Hyderabad, creating at least 1,500 new jobs in the State
- Niti-Aayog has chosen the Centre for Cellular and Molecular Biology (CCMB) for hosting the Atal Incubation Centre focussing on promising start-ups, in the field of biotechnology.
- The state is in the process of drafting the Vision 2030 Life Sciences policy to usher innovation and manufacturing in the State under the aegis of the Telangana Life Sciences Vision Group, in partnership with McKinsey & Company
- A Special purpose vehicle has been created for the Country's first Life Sciences Infrastructure Fund that was announced last year, with an aim to create assets in the life sciences sector which are worth at least Rs. 3,000 crores in the next two - three years.

- State Government will focus on more skill development activities in the sector by designing courses tailor-made for the sector.
- A world-class institute focused on Immunotherapy, personalized medicine and Nanomedicine to be established in the State
- Profiling of Companies and Academic institutions in Pharma and Life Sciences sector and preparation of databases collating all the information
- First of its kind Incubator focused for Vaccine Development in Genome Valley with an objective of developing at least one new vaccine in the State every year

HANDLOOM & TEXTILES

Handloom Industry in Telangana State occupies unique place in the country for its exclusive art and artifacts of handloom weavers. The design patterns of Pochampally Ikat, Gadwala Cotton, Silk & Sico Sarees, Narayanpet Cotton, Silk Sarees, Warangal Durries, Karimnagar Bed sheets & Furnishings shows the outstanding skills of handloom weavers.

Telangana state is also known for its production of high quality long staple cotton fibre with an annual production of more than 60 lakh bales.

Availability of high quality raw material and a large pool of workers having deep experience provides a rich opportunity to develop end-to-end value chain of Textiles and Apparel in the state.

The state government has geared up to address the same through various initiatives during the year:

Thrift Fund Savings and Security Scheme

- State Government has increased its share towards the Thrift Fund Scheme from existing 8% to16% to the Thrift Fund Account in order to implement the new version of Thrift Fund Scheme called Telangana Handloom Weavers Thrift Fund Saving and Security Scheme (TFSSS) and also approved its operational guidelines
- The basic objective of the scheme as announced is to inculcate thrift and provide social Security to the weavers.
- A lumpsum fund created for their future requirements with an allocation of Rs 60 Cr. this year



Chenetha Mithra Scheme Launch

- Hon'ble Textiles Minister KT Rama Rao launched a unique Chenetha Mitra scheme for the benefit of handloom workers in Warangal
- Envisaging 40% subsidy on the material required by the weavers
- Rs. 100 Cr. budget allocated



Loan Waiver Scheme

- Announced a loan waiver to benefit 2,467 handloom weavers, at a total cost of Rs 10 crore.
- The beneficiaries get loan waiver of up to Rs. 1 Lakh
- This scheme will waive off only the loans that were taken between 1 June 2014 and 31 March 2017

Telangana government distributed Bathukamma Sarees to over 1 cr. women

Initiative of the Hon'ble Chief Minister Shri K. Chandrashekhar Rao, where in women above the age of 18 years received this unique gift, irrespective of caste, creed or religion, providing a much needed fillip to the ailing powerloom sector in the State.

The sarees were distributed through ration shops over a period of three days starting from 18th Sept 2017.



In-situ Upgradation of Plain Powerlooms scheme

- The State Government took up the ambitious initiative of upgrading all power looms in Sircilla in a phased manner to enhance the income of weavers
- Union Government would provide 50 per cent assistance for upgrading looms and the remaining will be contributed by the State Government
- Each weaver or owner can upgrade up to eight looms.
- More than 5500 plain looms were upgraded this year.



Launch of Telangana Textile and Apparel Policy (T-TAP)

Telangana announced its Textile and Apparel Policy on 18th Aug 2017 to attract leading textile and apparel companies to invest in the state.

- Existing, as well as the upcoming units, will be benefitted from the policy
- Support for setting up new units and expansion / modernization by existing units under various heads viz. 



The progressive state industrial policy and the extensive outreach programme with the industry saw an unprecedented response from Automotive sector where a number of Automotive OEMs came forward with their Investments plans in the state.
- The year also saw some strategic partnership between Telangana state and leading Automotive OEMS, component suppliers and Automotive Tech Centres for development of a world class Automotive Ecosystem in the state. Telangana state further emerged as a strong Electric Vehicle Hub, driven by state focus on sustainable mobility solutions Urban Infrastructure. Re-investments from existing players and a strong interest from homebred investors and start-ups was another highlight of the year 2017-18 for Telangana Auto Industry
- The Automotive sector focus for the state was further expanded to include Locomotive, Construction equipment, farm equipment and other related industry sub-sectors to derive benefits of value chain synergies and create a robust ecosystem around the same.

Sustainable Automotive Technology Focus

 In cognizance of the emergence of Electric Vehicle technologies on the automotive landscape, Telangana state pro-actively aligned its Policy focus towards Electric Vehicle Technologies and related industries. In view of the existing strengths in IT and Electronics and a strong demand side marked by

A number of EV pilot were also rolled out through public institutions and private partnerships to test the policy recommendations against real market dynamics and saw tremendous participation from leading ecosystem players in the EV space.





- In this period TIHCL also assisted OTS and Revival package for reviving 23 entrepreneurs from Sirisilla Textile Park from financial collapse.


Way forward and Strengths

- Currently the operations are manual, but in the next 4 months TIHCL would be moving to a fully equipped technology face of online transactions with well-established standard operating procedures.
- MoU signed with SYSCON, ERP Solution provider, to effectively monitor the units assisted by TIHCL where by every enterprise that is assisted will have to set up ERP in its work place
- It continually keeps engaged in identifying the sectors that need facilitation from TIHCL and from the Govt. For example, secondary steel and handloom sectors have been studied at the request of the board.
- As per social cost-benefit analysis No. of sick units targeted are 560 which in turn helps to sustain employment of 5900 and also helps collection of taxes around Rs 3893.75 Cr.

- Out of 47 NPA or partially closed units approaching us for resolution, 60% were on sick bed due to nonfinancial problems – power failure or irregular power supply/ heavy commercial tax dues in arrears and strategic management issues. 38% were due to delayed release of incentives
- 12 more units in steel and aluminium sector suffered due to high power costs and lost their competitiveness compared to other neighbouring states.
- Study on skill requirements of manufacturing MSEs is being done by Development and Research services, at the behest of Planning Department of Government of Telangana in association with TIHCL, which is expected to be completed by the end of the May 2018.
- Data Analytics for the state flagship initiative TS-iPASS is being done by TIHCL. District wise position reveals that caution is needed both in the registrations and likely consequence of misuse of incentives.
- Stressed Asset Resolution of MSEs is not a charity but a sound business proposition.
- Stakeholders include MSEs, GMs of DICs, banks and financial institutions, industries associations and research organisations.
